TUITION PAYMENT OPTIONS FOR 2010-2011

Tuition balance only; no deposits or new student fees unless with full payment

****Families currently using FACTS who want to continue must contact Marynell Murphy 214-369-9201, ext. 343 if you have not already done so.**

PERSONAL CHECK, CASHIER'S CHECK, MONEY ORDER TO LAMPLIGHTER:

1. **One (1) Payment in full no later than June 1, 2010** by personal check, money order, or cashier's check. Payments are made payable and mailed to THE LAMPLIGHTER SCHOOL. These payments must be postmarked or received at the school no later than June 1, which is not a negotiable date. Families of new students admitted after June 1 should contact the Business Office for payment arrangements.

BANK PAYMENTS MAY BE SET UP ONLINE THROUGH SCHOOL WEBSITE LINK TO FACTS MANAGEMENT:

2. **One (1) Payment in full by Automatic Bank Payment** through checking or savings account must be signed up for on the FACTS website **no later than May 26, 2010**. There is a \$10 enrollment fee per student.
3. **Automatic Bank Payments** made through checking or savings account on the 5th or 20th of the month beginning in April, 2010 for 10 or fewer months to be completed no later than January 20, 2011. Interest of 6% will be charged and added to the tuition total for the extended tuition payments. The enrollment fee is based on # of payments.

CREDIT CARD PAYMENTS MAY BE SET UP ONLINE THROUGH SCHOOL WEBSITE LINK TO FACTS MANAGEMENT:

4. **One (1) Payment in full by credit card** (MasterCard, Visa, American Express, or Discover) must be signed up for on the FACTS website **no later than May 26, 2010**. There is a \$10 enrollment fee per student.
5. **Automatic MasterCard, Visa, American Express, or Discover Payments** made through credit card on the 5th or 20th of the month beginning in April, 2010 for 10 or fewer months to be completed no later than January 20, 2011. Interest of 6% will be charged and added to the tuition total for the extended tuition payments. The enrollment fee is based on # payments.

FOR PAYMENTS THROUGH FACTS: ENROLLMENT MUST BE COMPLETED THREE WEEKS PRIOR TO THE FIRST OR ONE TIME PAYMENT DATE.

Loan and Financial Aid information is available on the school website or from the Business Office.

NO STUDENT WILL BE ALLOWED TO START SCHOOL REGARDLESS OF DATE ADMITTED IF THE TUITION IS NOT PAID IN FULL OR PAYMENT ARRANGEMENTS HAVE NOT BEEN MADE BY MONDAY, AUGUST 9, 2010. NO STUDENT WILL BE ALLOWED TO REMAIN IN SCHOOL NOR WILL RECEIVE A RE-ENROLLMENT AGREEMENT FOR THE FOLLOWING SCHOOL YEAR UNLESS ALL PAYMENTS THROUGH THE AVAILABLE PAYMENT PLAN ARE CURRENT.
