The Board of Trustees, after a detailed study of school costs and in consultation with legal counsel, has adopted the policy that no refunds or transfers of tuition, deposits, or fees shall be made. While the Board is sympathetic to parents and changes in their circumstances, based on contracts which parents sign, the School in turn contracts with staff and incurs other costs. It must, therefore, take the position that all tuition, deposits, and fees are deemed earned when enrollment contracts are executed by both parties.
